## 2013 UNDERGRADUATE ADMISSION APPLICATION

### **APPLICATION DEADLINE**

The undergraduate major is a limited access program requiring a School application. Meeting the application eligibility requirements does not guarantee admission. Admission is available for the summer/fall semesters only and requires a minimum of two years to complete. Please note that major coursework begins in the fall semester.

To be considered for admission, students must complete the online registration form AND submit their paper-based application to the College of Communication and Information Advising Center University Center C, Suite 4115, by February 1, 2013 by 5 PM EST. Paper-based applications can be submitted beginning January 7, 2013.

**Students will be sent notification regarding their acceptance or denial through the e-mail address as listed on their online "Undergraduate Application Registration Form". Decisions will be released on Friday, March 1, 2013 by 5PM.**

### **APPLICATION SUBMISSION ELIGIBILITY**

**Students who wish to major in Communication Science & Disorders must have fulfilled the following requirements by February 1, 2013, in order for the application to be reviewed:**

1. Have an all-college **GPA of a 3.0** or higher through fall 2012
2. Liberal Studies course substitutions, if applicable, must be approved by the appropriate dean and posted to the transcript.
3. All college credit must be posted to the transcript. Examples include, but are not limited to: AP, AICE, IB, dual-enrollment, CLEP and transient coursework.
4. All coursework for application eligibility must be reflected on submitted transcripts and/or spring 2013 class schedules by the application deadline

**In addition, students who wish to major in Communication Science & Disorders must fulfill the following requirements, or earn an AA degree from a Florida public community-college or university, by the end of the spring semester 2013:**

1. All FSU **Liberal Studies** courses must be successfully completed
2. All FSU **Gordon Rule** courses must be successfully completed
3. Complete a minimum of **52 hours** of undergraduate coursework accepted by FSU

**\*\*If you do not meet all of the requirements stated above, you may not turn in an application for review\*\***

#### **Completion of AA in spring 2013**

- A student transferring to Florida State University from a Florida public community/junior college or senior institution will be deemed to have satisfied the University's liberal studies and Gordon Rule requirement if all general education requirements stipulated by the community/junior College or senior institution have been met and are reflected on the student's transcript.
- A student transferring to Florida State University from a private or out-of-state community/junior college or senior institution will have their transcripts evaluated to determine if the student has met the University's Liberal Studies and Gordon Rule requirements as set by Florida State University.

#### **Completion of AA in summer 2013**

- Regardless of the transferring institution, application eligibility will be determined based on whether the student has completed all of the Universities Liberal Studies and Gordon Rule requirements as set by Florida State University by the end of the spring 2013 semester. It is expected that the student will utilize the summer 2013 semester to complete remaining elective credits needed to complete the AA degree as set by the student's current institution.

#### **TRANSFER STUDENTS MUST ALSO INCLUDE THE BELOW INFORMATION AS PART OF THE SCHOOL OF COMMUNICATION SCIENCE & DISORDERS APPLICATION PACKAGE:**

- Official Transcript (include as part of your application package. DO NOT send transcripts separately).
- Students receiving an AA in spring 2013 must provide proof of graduation. Proof is defined as a completed application to graduate (which must have a signature of a university official) or letter from the Registrar indicating when the AA degree will be completed. Failure to provide such information will result in the student being evaluated according to Florida State University's individual Liberal Studies and Gordon Rule requirements.
